This also opens up any Federal Government funding or State Government funding because we have declared an Emergency Declaration.

The Mayor also wanted to say he is proud of the community, the churches, the small businesses and restaurants, please keep them in mind, the churches have services on line, and restaurants are doing curb side services. Please support our local community.

SOLICITOR: A copy of the Solicitor's report on file Chip asked to have the Declaration ratified. Once it is ratified it will last until the Mayor lifts it.

BOROUGH OPERATIONS MANAGER: A copy of the BOM's report is on file. Les said they have provided some bags for the parking meters to help with curb side service. She stated that Discover.com is also pushing out different activities for children and adults to do. We have restricted access to the office, we will have an intercom service to help, and will have our door locked. This is all to protect our staff. Mason will be working on our website, he will update it. The Clearfield School District has a program for breakfast and lunch for the children. Our trucks are out doing curb side pick ups.
